U-bidit.com, LLC (“U-bidit.com,” “we,” “our,” or “us”) understands that your privacy is important and this policy explains how we protect that privacy, the data we collect, and how we use that data when you use our website, software, or services (“Services”). Please read this Privacy Policy in full before using the Services. We may revise this Privacy Policy at any time and will post the date of the latest update above. What We Collect

We collect and use the information below to provide and improve the Services of U-bidit.com.

User Account Information

We collect the information you provide when setting up your account directly with U-bidit.com such as your name, email address, phone number, and address. We also collect your information if you access our Services through Facebook. If you access our Services through Facebook, you may also allow us to have access to information on your Facebook profile, including demographic information, your interests, and other information you share through Facebook. Facebook has its own privacy policy, and you should read that privacy policy to understand how Facebook shares your information.

Other Information

When you use the Services, we collect information related to the devices on which you are using our Services. We may collect this information using analytics software such as Google Analytics. Examples of such information include the type of device, type of browser, IP addresses, the website you visited before ours, and other identifiers associated with your device, including your location.

Cookies and Similar Technologies

Like many other Services, we use cookies and other similar technologies such as web beacons to collect information. Cookies are data stored on a hard drive that help us improve your use of our site and enhance our ability to track and enhance user experiences on our site. You have the right and ability to tell change the settings on your browser to refuse cookies, but note that if you do so, you may not be able to access our Services with full functionality.

We may use flash cookies, also known as local shared objects, that assist in delivering content such as video clips or animations. These flash cookies are stored on your device. Note that you can modify your browser setting so disable all types of cookies, including flash cookies.

Use and Sharing of Your information

We use your information for the following reasons: for the purposes you provide it, such as setting up a user profile and using the Service; for customer service; for marketing purposes; and for research and analytics purposes. U-bidit.com may share your information as discussed below, but we will not sell your information to third parties.

Other Service Providers

U-bidit.com uses other service providers to help give you the best experience with U-bidit.com.
